  - (ii) Panchayat or other Competent Authority in case of the areas are not covered in MunicipalLimits of Metro Cities, State Capitals and District Headquarters.
- 3. (a) A Cumulative Fixed Deposit only in a Nationalized Bank in the joint name of Trust/Society and the concerned Regional officer for a period of 10 years for the amount as applicable to the category of the institution indicated in the amexure to this letter(Annexure I). FDR should be created by duly obtaining the signature of the concerned Regional Officer on the FDR application form 'A'. (Please also refer the Procedure for creation of FDR at Annexure II). FDR should be cheked only in the Branch for which the signature of the concerned Regional Officer was obtained.


